## 0. Opening

Erkki Ikonen opened the meeting at 4:20 PM.

### 1. Adoption of the agenda

The agenda was adopted. It was decided that after item 3, the time scales of the Network from WS 4 until the end of the project would be discussed.

## 2. Progress of the working groups

- WG 1: The final draft of the document "Characterizing the performance of integral measuring UV meters" is ready to be accepted in the WG meeting.
- WG 2: The documents are somewhat unfinished but are expected to be finalised in time to be published with the other documents. WG 2 concentrates on two main areas and specific subjects within the areas.
- WG 3: Group has decided not to produce documents. Instead, WG 3 has concentrated on specific issues raised within WG 1. The solutions developed have been included in the draft of WG 1.
- WG 4: The final drafts of the produced documents are ready to be discussed in the WG meeting.

Publication of the WG reports was discussed. It was concluded that in addition to web-publishing, paper copies are needed. They need to be published in a medium that can be referred to. Therefore, it was decided that all documents would be combined in a special issue of UVNews (Issue 6). 20 extra copies of UVNews 6 will be given to WG leaders (50 to A.G-H.)

# 3. Finalising the programme of the Borås workshop

WG 3 report was deleted on Thursday. The last coffee break was moved to the end of the day before the poster session. The departure time of the bus remains at 6 PM.

Arrangement of the 5. Workshop was discussed. It was decided that the Network tries to arrange a Workshop in Greece in year 2002, which will be proposed to the participants. Alkis Bais of Aristotle University of Thessaloniki has preliminarily agreed to assist with the practical arrangements.
